## Article 2

### FORMAT AND DELIVERY OF CROATIAN STANDARDS

- A. Croatian standards are available in hardcopy and electronic formats (PDF), except those with more than 321 pages (price groups XA and HXA and up, respectively), which are available only in electronic format (PDF).
- B. Croatian standards ordered in electronic format (PDF) and/or network licences to Croatian standards are delivered by registered post, taken over in person on HZN's premises or sent by e-mail.
- C. Croatian standards ordered in hardcopy format are delivered by registered post or taken over in person on HZN's premises. Delivery charges for registered post are HRK 40.00 / EUR 5.31.

## Article 3

### DISCOUNT ON CROATIAN STANDARDS

- A. The following mutually exclusive discounts are granted on the price of Croatian standards (Article 1, Tables A and B):
  - 20 % for HZN members and educational institutions
  - 20 % for governmental bodies unless stipulated otherwise by a separate contract
  - 33 % for national standardising bodies of other countries
  - 50 % discount for full-time students upon presentation of a proof of student status
  - 50 % discount for draft Croatian standards in the Croatian language
- B. For the purchase of more than one copy of the same Croatian standard in one purchase order, the following discounts are granted:

## Article 4

### COPYRIGHT FEE FOR CROATIAN STANDARDS

#### A. COPYRIGHT FEE FOR NETWORK LICENCE

The copyright fee for usage on customer networks is calculated for each user enquiry separately. Calculation of the copyright fee is based on the number and price of Croatian standards, number of end users and sites on the network. ISO's Excel spreadsheet for calculation of copyright fee for granting copyright exploitation rights for internal use of standards in electronic format is used for calculation.

The fee is based on a minimum of two (2) users. Discount from Article 3(A) is applied on the copyright fee for network licence.

### C. REPRODUCTION (COPIES) FOR COMMERCIAL PURPOSES

Price of reproductions (copies) of Croatian standards for commercial purposes is available upon request.

Discounts from Article 3(A) do not apply to Croatian standards purchased for the reproduction for internal use.

Croatian standards purchased for the reproduction are delivered in electronic format and printed out by the user.

### D. FEE FOR THE USE OF PARTS OF CROATIAN STANDARDS

The fee for the reproduction of parts of Croatian standards for commercial purposes is available upon request. It depends on the total number of pages or overall content reproduced, which may not exceed 25 % of the customer's publication, product or service the material is reproduced in.

The right to reproduce parts of Croatian standards is based on a proof of purchase of the relevant standard.

## Article 5

### REPOSITORY OF CROATIAN STANDARDS

A. The terms of annual or semi-annual subscription to the Repository for professional chambers, associations and societies with a large number of members, governmental bodies and organizations with a large number of employees and similar organizations are defined by agreement.

The fee depends on:

- current price of the collection of Croatian standards
- total number of Croatian standards in the collection
- number of users with access to the Repository, the minimum number being two (2).

Discount from Article 3(A) applies to annual and semi-annual subscriptions to the Repository.

## **Article 7**

### **MEDIATION IN THE PURCHASE OF OTHER FOREIGN STANDARDS**

- A. HZN may mediate in the procurement of other foreign standards only in hardcopy format. An exception are standards for which the publisher/supplier has approved the delivery in electronic format. Other foreign standards delivered electronically have been protected by the publisher/supplier. HZN cannot influence the publisher/supplier's terms of protection for the standard purchased.
- B. The price of standards ordered is expressed as the HRK equivalent of the publisher/supplier's list price until 1 January 2023 and thereafter in euros. The price of the ordered normative documents is the publisher/supplier's list price plus 20 % of the order value or HRK 150,00/EUR 19.91, whichever is higher, and the postage for delivery from the foreign publisher/supplier to HZN.
- C. The HRK equivalent is calculated based on the mean rate of the Croatian National Bank valid on the last working day of the month for the following month.
- D. Delivery deadlines depend on the delivery to HZN. Information on the delivery deadline is given on the pro-forma invoice for each individual order.
